



PRODUCE FOR KIDS® & MELISSA'S PRODUCE FREAKY FRUITS SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Entry Period. The Produce for Kids & Melissa's Produce Freaky Fruits Sweepstakes ("Sweepstakes") begins October 1, 2017 at 12:01am EST ("Start Date") and ends October 31, 2017 at 11:59pm EST ("Sweepstakes Period"). This Sweepstakes is void where prohibited or restricted by law.
2. Eligibility. The Sweepstakes is open to individual legal residents of the 50 United States and the District of Columbia, age 18 or older as of the Start Date. All submitted entries become the property of Sponsor and will not be acknowledged or returned; Sponsor is not responsible for lost, late, inaccurate, incomplete, damaged, illegible, or misdirected entries. 4. Selection of Winners. One (1) grand prize winners will be selected from among all eligible entries received in a random drawing ("Drawing"). The Drawings will occur on or about November 2, 2017. The winners will be notified within 48 hours by email at the email address provided upon entry.
