



**PRODUCE FOR KIDS® & SUPERFRESH GROWERS AUTUMN GLORY® SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Entry Period. The Produce for Kids & Superfresh Growers Autumn Glory Sweepstakes (“Sweepstakes”) begins January 14, 2019 at 12:01am EST (“Start Date”) and ends January 27, 2019 at 11:59pm EST (“Sweepstakes Period”). This Sweepstakes is void where prohibited or restricted by law.
2. Eligibility. The Sweepstakes is open to individual legal residents of the 50 United States and the District of Columbia, age 18 or older as of the Start Date. 4. Selection of Winners. One (1) winner will be selected from among all eligible entries received in a random drawing (“Drawing”). The Drawing will occur on or about February 1, 2019. The winners will be notified on or about February 1, 2019 by email at the email address provided upon entry.
5. Prizes and Odds. One (1) grand prize winner will each receive one (1) \$50 VISA gift card and one (1) 12-pack sample box of Autumn Glory apples (provided by Superfresh Growers). Odds of winning depend upon the number of eligible entries received. Sponsor reserves the right to substitute prizes of equal or greater value. No other substitution or transfer of prizes permitted. Sponsor is responsible only for prize delivery; not responsible for prize utility, quality or otherwise. Taxes and fees, if any, are the sole responsibility of the winner.
