



## PRODUCE FOR KIDS® POWER YOUR SUMMER SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Entry Period. The Produce for Kids Power Your Summer Sweepstakes (“Sweepstakes”) begins May 27, 2019 at 12:01am EST (“Start Date”) and ends August 4, 2019 at 11:59pm EST (“Sweepstakes Period”). This Sweepstakes is void where prohibited or restricted by law.
2. Eligibility. The Sweepstakes is open to individual legal residents of Canada (excluding Quebec), as well as the 50 United States and the District of Columbia, age 18 or older as of the Start Date. Produce for Kids and its subsidiaries, affiliates, sales representatives, and any other parties associated with the development and execution of this Sweepstakes (and their immediate families and members of the same household) may not participate in this Sweepstakes.
3. How to Enter. To enter, you must: (1) go to <https://www.produceforkids.com/poweryoursummer/> (“Event Webpage”), then (2) complete the Entry Form and click submit. All information provided by the entrant (“Entrant”) must be complete, true and correct. All submitted entries become the property of Sponsor and will not be acknowledged or returned; Sponsor is not responsible for lost, late, inaccurate, incomplete, damaged, illegible, or misdirected entries. Limit one entry per email address per week. **All entries must be submitted by August 4, 2019.** Information collected as part of this Sweepstakes will only be used as described in Sponsor’s privacy policy, available at <http://www.produceforkids.com/site/privacy.html>.
4. Selection of Eligible Winners. One (1) eligible prize winner will be selected each week from among all eligible entries received in a random drawing (“Drawing”). The Drawings will occur weekly from May 27, 2019 to August 4, 2019. The eligible winners will be notified within 5 days by email at the email address provided upon entry.
5. Prizes and Odds. Confirmed prize winner will receive one (1) poolside prize ranging from pool floats to beach towels. Prizes will be announced each week on the Produce for Kids social pages and the Event Webpage (estimated retail value of prizes: \$25-50, provided by Produce for Kids). Odds of winning depend upon the number of eligible entries received. Sponsor reserves the right to substitute prizes of equal or greater value. No other substitution or transfer of prizes permitted. Sponsor is responsible only for prize delivery; not responsible for prize utility, quality or otherwise. Taxes and fees, if any, are the sole responsibility of the winners.

6. Verification of Winner and Delivery of Prize. Each eligible winner may be required to sign an affidavit of eligibility and liability release and, a publicity release (known as a declaration and release for residents of Canada) (unless prohibited by law). In addition, any eligible winner who is a resident of Canada will be required to correctly answer a mathematical skill-testing question without mechanical or other aid (which may, in the sole and absolute discretion of the Sponsor, be administered online, by email or other electronic means, by telephone, or in the Sponsor’s form of declaration and release). Failure to correctly answer the skill-testing question will result in disqualification.
